In consideration of being permitted to participate in Basketball tournaments and/or leagues the ("Activity") conducted by Brookline Recreation Commision, and by signing this form, I, for myself, my spouse, legal representatives, heirs and assigns, hereby release, waive and discharge each of them, from all liability to me, my spouse, legal representatives, heirs and assigns, for any and all loss or damage, and any claim or damages resulting there from, on account of injury to my person or property, even injury resulting in my death, whether caused by negligence or otherwise, while I am competing, officiating, working or for any purpose participating in the Activity.

I acknowledge that basketball involves risks and I hereby assume full responsibility for the risk of bodily injury, death or property damage, whether due to negligence or otherwise, while in or upon Brookline Recreation Commisions, Brookline Schools, and/or any other facilities connected with Brookline Recreation Commision (the "Property") and while competing, officiating, working or for any purpose participating in the Activity.

I agree to indemnify the Releases and each of them from any loss, liability, damage or cost they may incur due to my presence in or upon the Property, whether caused by negligence or otherwise.

I expressly agree that this release, waiver, and indemnity agreement is intended to be as broad and inclusive as permitted by law, and that if any portion hereof is held invalid, it is agreed that the balance shall continue in full legal force and effect.
